BOROUGH OF PENNS GROVE COUNTY OF SALEM, STATE OF NEW JERSEY MAYOR AND COUNCIL REGULAR MEETING JUNE 2, 2020 MINUTES

This Borough Council meeting was held remotely via the ZOOM platform on the above date and called to order by Mayor LaDaena D. Thomas. Mayor Thomas gave the Open Public Meeting statement.

Mayor Thomas led the Pledge Of Allegiance.

Invocation by Sharon R. Williams, Clerk.

Attendance: Bercute – present, Mincey-present, Oliver-present, Pasquale-present, Scott-absent, Washington, Jr.-present.

MINUTES: May 11, 2020 – special meeting. Motion to adopt by Oliver; second Mincey. Roll call. All ayes.

<u>2020-2</u> – CALENDAR YEAR 2020 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S.A 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.50% unless authorized by ordinance to increase it to 3.50% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.50% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Council of the Borough of Penns Grove in the County of Salem finds it advisable and necessary to increase its CY 2020 budget by up to 3.50% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Council of the Borough of Penns Grove hereby determines that a 1.00% increase in the budget for said year, amounting to \$43,529.51 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Council of the Borough of Penns Grove hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Council of the Borough of Penns Grove, in the County of Salem, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2020 budget year, the final appropriations of the Borough of Penns Grove shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.50%, amounting to \$152,353.29, and that the CY 2020 municipal budget for the Borough of Pennsgrove be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction;

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

Motion to open meeting to the public by Oliver; second Mincey. All in favor.

Motion to close meeting to the public by Mincey; second Pasquale. All in favor.

Motion to adopt by Pasquale; second Mincey. Roll call. All ayes.

BUDGET HEARING.

Stephen Labb, Finance Officer, stated the need to hold public hearing on the 2020 Municipal Budget, with an anticipation of 85 percent of the 2019 Transitional Aid award will result in a local increase of \$.29 cents. Labb stated that the average assessed home is \$87,000.00, equaling an increase of \$25.09 per year.

Public Comment: Motion to open meeting to the public by Mincey; second Mincey. All in favor. Motion to close meeting to the public by Mincey; second Pasquale. All in favor.

Motion to Table by Oliver; second Pasquale. Roll call. All ayes.

COMMITTEE REPORTS:

Buildings & Grounds: Pasquale reported the following: grass cutting equipment repaired and in use on Borough owned properties. Walking lawnmower needed. Two properties boarded up. Conveyed to Police to remove and report and vagrants found. Borough Hall carpets cleaned, sprayed and disinfected. Unsuccessful with roof repair due to COVID19, however, quotes have been received. Clean up of old former Public Works building.

Mayor questioned detail of "board up".

Pasquale stated 2' x 4' boards were used at 41 and 159 ½ East Main Street, to secure entrances.

Mayor questioned the number of properties to be secured; and the role Carneys Point plays. Pasquale stated that the Borough currently owns 89 properties and that Carneys Point does not assist with the board; contractors have been hired to secure Borough owned properties. Oliver questioned if all are Borough owned.

Pasquale stated that the 89 properties are currently Borough owned. Pasquale further stated that liens can be placed against the property that aren't Borough owned, where grass cutting or securement take place.

Temporary Capital Budget Resolution, which provides for the acquisition of various computer equipment. Capital Ordinance, by title, for the acquisition of computer equipment. State Contract Resolution for the purchase of the Live Scan System.

Chief of Police Report: Chief Riley stated/addressed the following: Police Report for the month of April 1, 2020 through May 31, 2020. Changes in scheduling in order to protect the officer and citizens from exposure to COVID 19, while maintaining public safety. Employee Assistance Program. WHEREAS, the need has arisen to introduce a capital ordinance to provide funds for Various Improvements within the Borough of Penns Grove prior to adoption of the 2020 Capital Budget, and; WHEREAS, the regulations of the Local Finance Board (N.J.A.C. 5:30-4.3(b)) of the Division of Local Government Services, Department of Community Affairs requires that a municipality adopt a temporary capital budget if a capital ordinance is to be passed prior to adoption of the Annual Capital Budget; NOW, THEREFORE, BE IT RESOLVED, by the Governing Body of the Borough of Penns Grove, County of Salem that:

Section 1. 2020 Temporary Capital Budget is hereby created for the following:

2020-5-90 – RESOLUTION AUTHORIZING THE APPOINTMENT OF CONFLICT COUNSEL

WHEREAS, the Borough of Penns Grove is in need of Conflict Counsel to handle certain legal matters which are determined by the current Solicitor to be a conflict for him to handle; and WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-5(1)(a)(1) authorizes a governing body to enter into a contract for professional services without advertising for bids and bidding; and WHEREAS, the value of the contract for Conflict Counsel shall not exceed the total sum of \$17,500.00 and therefore the Fair and Open process is not required in order to issue this contract. This contract shall be effective for a period of time beginning on the date in which the contract is approved by the New Jersey Department of Community Affairs and ending December 31, 2020.

In consideration for services to be rendered, this position shall be compensated by an hourly rate of \$ _____145.00 .

This appointment shall be conditioned upon the execution of a written contract, signed by the Conflict Counsel, setting forth the terms of the employment which shall be consistent with the content of this resolution and satisfactory to the Borough.

This appointment is awarded without competitive bidding as a professional service contract under the provisions of the Local Public Contracts Law.

2020-3 - AN ORDINANCE CHANGING APPROPRIATE AUTHORITY

WHEREAS, N.J.S.A. 40A:14-118 provides for the establishment of an Appropriate Authority, whom the Chief of Police shall be directly responsible to; and

WHEREAS, Section 116-2(B)(1) of the Code of the Borough of Penns Grove states that the Chief of Police shall be directly responsible to the Appropriate Authority for the day-to-day operation of the Police Department pursuant to policies established by said Appropriate Authority; and

WHEREAS, Section 116-2(B)(1) further states that the Mayor shall be the Appropriate Authority; and WHEREAS, the governing body has determined that the Appropriate Authority shall be changed from the Mayor to the Police Committee, which is authorized pursuant to N.J.S.A. 40A:14-118.

NOW THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Penns Grove that Section 116-2(B)(1) of the Code of the Borough of Penns Grove shall be changed to read that the Appropriate Authority shall be the Police Committee.

- a) The purpose described in Section 1 is not a Current Expense and is an improvement, which the Borough may lawfully make as a general improvement.
- b) The period of usefulness of the purpose described in Section 1 hereof is within the limitations of the Local Bond Law and according to the reasonable life thereof is five (5) years or more.
- c) No debt is authorized by this ordinance.
- d) The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services, is on file with the Borough Clerk and available for inspection.

SECTION 3: All ordinances or parts of ordinances that are inconsistent with the terms of this ordinance be and the same are hereby repealed to the extent of their inconsistency.

Mr. Martin stated his favor of Zoagies presence on Virginia Avenue.

Sue Oliver, Church Street, expressed concern regarding Zoagies customer parking along Virginia Avenue and Willis Street.

Motion to close meeting to the public by Washington; second Mincey. All in favor.

ADJOURNMENT: Motion to adjourn by Washington, second Oliver. All in favor.
