2019-1-20 – GOVERNOR'S COUNCIL ON ALCOHOLISM AND DRUG ABUSE FISCAL GRANT CYCLE JULY 2019 - JUNE 2020

WHEREAS, the Governor's Council on Alcoholism and Drug Abuse established the Municipal Alliances for the Prevention of Alcoholism and Drug Abuse in 1989 to educate and engage residents, local government and law enforcement officials, schools, nonprofit organizations, the faith community, parents, youth and other allies in efforts to prevent alcoholism and drug abuse in communities throughout New Jersey.

WHEREAS, The <u>Borough of Penns Grove</u> Council of the <u>Borough of Penns Grove</u>, County of <u>Salem</u>, State of New Jersey recognizes that the abuse of alcohol and drugs is a serious problem in our society amongst persons of all ages; and therefore has an established Municipal Alliance Committee; and,

WHEREAS, the <u>Borough of Penns Grove</u> Council further recognizes that it is incumbent upon not only public officials but upon the entire community to take action to prevent such abuses in our community; and,

WHEREAS, the <u>Borough of Penns Grove</u> Council has applied for funding to the Governor's Council on Alcoholism and Drug Abuse through the County of Salem;

NOW, THEREFORE, BE IT RESOLVED by the <u>Borough of Penns Grove</u> of County of <u>Salem</u>, State of New Jersey hereby recognizes the following:

1. The <u>Borough of Penns Grove</u> Council does hereby authorize submission of a strategic plan for the <u>Borough of Penns Grove</u> Municipal Alliance grant for fiscal year <u>2020</u> in the amount of:

> <u>2019-1-21</u> – A RESOLUTION AUTHORIZING THE APPOINTMENT OF MUNICIPAL ENGINEER FOR THE BOROUGH OF PENNS GROVE

WHEREAS, the Borough of Penns Grove has determined that it shall use a fair and open process to acquire certain services in accordance with the provisions of N.J.S.A. 19:44A-30.5; and

WHEREAS, N.J.S.A. 19:44A-20.5 provides that contracts awarded through a fair and open process may be awarded based on price and other factors; and

WHEREAS, the Borough of Penns Grove has a need to acquire the services of Municipal Engineer as a fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.5; and

WHEREAS, the Borough of Penns Grove's Chief Financial Officer has determined and certified in writing that the value of these services will likely exceed \$17,500.00; and

WHEREAS, the local public contracts law N.J.S.A. 40A:11-1, et. seq. requires that the Resolution authorizing the award of contracts for "professional services" be publicly advertised; and

WHEREAS, Request for Proposals were submitted, and the opening was held on the 7th day of December 2018; and WHEREAS, Sickels & Associates, Inc., were the only firm to submit a proposal to provide Municipal Engineering services for the Borough of Penns Grove; and

WHEREAS, funding for this contract shall be encumbered by the Borough of Penns Grove's Chief Financial Officer in accordance with N.J.A.C. 5:30-5.4;

NOW, THEREFORE BE IT RESOLVED by the governing body of the Borough of Penns Grove as follows.

- 1. This appointment is subject to the review and approval of the Division of Local Government Services.
- 2. Sickels & Associates, Inc., Woodbury, New Jersey is hereby awarded a contract, pursuant to a fair and open process, to provide Engineering Services for the

Borough of Penns Grove, effective January 1, 2019 and terminating December 31, 2021, which services shall be performed in accordance with the terms and conditions contained in the attached supplemental documents which are filed in the Office of the Municipal Clerk.

- 1. The Mayor and Borough Clerk are hereby authorized to execute the written contract setting forth the terms of employment, which shall be consistent with this resolution and satisfactory to the Borough and the Borough Solicitor.
- 2. A notice awarding this contract shall be published in the South Jersey Times, as required by law, within ten (10) days after passage.
