#### 6. BUDGET:

<u>2019-4-69</u> – RESOLUTION TO AVERAGE TAX COLLECTION RATE FOR USE IN THE 2019 MUNICIPAL BUDGET WHEREAS, the Borough of Penns Grove experienced a decline in the tax collection rate for the year 2018; and

WHEREAS, the use of the lower collection rate in arriving at the budget appropriation Reserve for Uncollected Taxes in the 2019 Municipal Budget would result in an unfair tax burden to the taxpayers of the Borough of Penns Grove; and

WHEREAS, the Division of Local Government Services, Department of Community Affairs will allow the Borough of Penns Grove to use the average of the prior three years' collection rates in calculating the budget appropriation Reserve for Uncollected Taxes in the 2019 Municipal Budget; and

WHEREAS, the prior three years' collection rates are 86.57% for 2015, 87.38% for 2016 and 85.74% for 2017; and

WHEREAS, the averaging of the prior three years' collection rates result in a collection rate of 86.56%; NOW, THEREFORE, BE IT RESOLVED that the Borough of Penns Grove will use the collection rate of 86.31% in calculating the budget appropriation Reserve for Uncollected Taxes in the 2019 Municipal Budget.

### ORDINANCE: 2019-4 – CALENDAR YEAR 2019 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14) \*TITLE ONLY\*

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.50% unless authorized by ordinance to increase it to 3.50% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.50% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Council of the Borough of Penns Grove in the County of Salem finds it advisable and necessary to increase its CY 2019 budget by up to 3.50% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Council of the Borough of Penns Grove hereby determines that a 1.00% increase in the budget for said year, amounting to \$43,710.28 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

WHEREAS, the Council of the Borough of Penns Grove hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years;

NOW THEREFORE BE IT ORDAINED, by the Council of the Borough of Penns Grove, in the County of Salem, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2019 budget year, the final appropriations of the Borough of Penns Grove shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.50%, amounting to \$152,986.09, and that the CY 2019 municipal budget for the Borough of Penns Grove be approved and adopted in accordance with this ordinance; and

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

#### 2019-4-66 - RESOLUTION TO INTRODUCE THE 2019 MUNICIPAL BUDGET

BE IT RESOLVED, by the Borough Council of the Borough of Penns Grove, the governing body thereof, that the 2018 Budget for the Borough of Penns Grove be introduced, approved and given first reading by title only;

### <u>2019-4-68</u> – RESOLUTION AUTHORIZING THE BOROUGH OF PENNS GROVE TAX COLLECTOR TO PREPARE AND MAIL ESTIMATED TAX BILLS IN ACCORDANCE WITH P.L. 1994, C. 72

WHEREAS, the Borough of Penns Grove has scheduled budget adoption pending notification of transitional aid application award and the County of Salem Board of Taxation is unable to certify the Borough of Penns Grove tax rate at this time and the Borough of Penns Grove Tax Collector will be unable to mail the Borough's 2019 tax bills on a timely basis; and

WHEREAS, in accordance with Chapter 72, P.L. 1994, the Borough of Penns Grove Council does not need approval from the Director of the Division of Local Government Services since the estimated tax levy will not exceeding 105% maximum allowed. Approval will enable the Borough of Penns Grove to meet its financial obligations, maintain the tax collection rate, provide uniformity for tax payments, and save the unnecessary cost of interest borrowing; NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Penns Grove, County of Salem and State of New Jersey on the April 2, 2019 as follows:

- 1. The Borough of Penns Grove Tax Collector is hereby authorized and directed to prepare and issue estimated tax bills for the Borough for the third installment of 2019 taxes. The Tax Collector shall proceed upon approval from the Director and take such actions as are permitted and required by L. 1994, c. 72 (N.J.S.A. 54:4-66.2 AND 54:4-66.3).
- 2. The entire estimated tax levy for 2019 is hereby set at \$ 6,954,707.98
- 3. In accordance with law, the third installment of 2019 taxes shall not be subject to interest until the later of August 10<sup>th</sup> or the twenty-fifth calendar day after the date the estimated tax bills were mailed. The estimated tax bills shall contain a notice specifying the date on which interest may begin to accrue.
