# <u>2019-9-138</u> – AN RESOLUTION AUTHORIZING EXTENDING THE GRACE PERIOD FOR THE NOVEMBER 2019 TAX QUARTER

# <u>2019-9-143</u> – A RESOLUTION OF THE BOROUGH OF PENNS GROVE AUTHORIZING ACCEPTANCE OF FISCAL YEAR 2018 ASSISTANCE TO FIREFIGHTERS GRANT

WHEREAS, the Borough of Penns Grove Ambulance Department has applied for the Fiscal Year 2018 Assistance to Fire Fighter Grant from Department of Homeland Security; and

WHEREAS, the purpose of the Assistance to Firefighters Grant program is to protect the health and safety of the public and firefighting personnel against fire—related hazards. FEMA has determined that the recipient's project (purchase of an Ambulance) was consistent with the Assistance to Firefighters Grant Program's purpose and was worthy of award; and
