ORDINANCE NO. 2021-27

AN ORDINANCE AMENDING CHAPTER 141, SECTION 3 REGARDING MEMBERSHIP, TERMS AND VACANCIES FOR THE ECONOMIC AND REDEVELOPMENT BOARD

NOW THEREFORE BE IT ORDAINED AS FOLLOWS:

SECTION 1.

ARTICLE II, SECTION 141-3. Membership, Terms and Vacancies, shall be

amended to add the following provision which is underlined:

- A. The Penns Grove Economic Redevelopment Board shall be comprised of the following regular members:
 - 1. One appointment by each Borough Council member currently serving;
 - 2. Four appointments by the Mayor;
 - 3. The first three appointments by the Council and the first two appointments by the Mayor shall be for a term of two years. The following three appointments by Council and the following two appointments by the Mayor shall be for a term of three years. Thereafter, each appointment shall be for a term of three years.
- **SECTION 2.** The remainder of all other sections and subsections of the aforementioned ordinance not specifically amended by this Ordinance shall remain in full force and effect.
- **SECTION 3.** All other ordinances in conflict with or inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.
- **SECTION 4.** If any portion of this ordinance is adjudged unconstitutional or invalid by a court of competent jurisdiction, such judgment shall not affect or invalidate the remainder of this ordinance but shall be confined in its effect to the provision directly involved in the controversy in which such judgment shall have been rendered.
- **SECTION 5.** This ordinance shall become effective twenty (20) days after final passage and advertisement thereof as required by law.
