# BOROUGH OF PENNS GROVE COUNTY OF SALEM, STATE OF NEW JERSEY MAYOR AND COUNCIL MEETING MINUTES JUNE 5, 2019

The Regular Meeting of the Borough of Penns Grove Council was called to order by Mayor Washington, Sr., at 7:21 p.m.

The meeting was held in the Court Room of the Borough Hall Municipal Building at 1 State Street, Penns Grove,

New Jersey, 08069

In accordance with section 5 of the Open Public Meetings Act, Chapter 231 P.L 1975, Notice of this meeting was posted on the Borough of Penns Grove Municipal Bulletin Board designed for that purpose. Everyone participated in the flag salute.

Invocation was led by Deputy Clerk.

Present were: Mayor Washington, Sr., Councilman Lou Pasquale, Councilwoman Deborah Scott, and Councilman Carl Washington, Jr. Also, present were: Borough Solicitor Adam Telsey, Deputy Clerk Kayla Veltman, and Assistant Treasurer Ericka Walker.

Absent Were: Councilman Rafael Leon, Councilman Mark Oliver, and Council- President Clifford Poindexter.

Deputy Clerk read correspondence received by Department of Agriculture Division of Plant Industry, with request to report spotted Lanternfly.

Deputy Clerk read an open letter received from Walter L. Hudson, Sr., as it expresses concern of the series of shootings within the community, Three (3) Victims of gun violence and the death of Tayshon Hayward also known as "Sapp".

Deputy Clerk notified the public on behalf of Atlantic City Vegetation Management, whereas Tree pruning and removal within the next Two (2) to Three (3) weeks will be active at the following locations: East and West Main Street, North and South Broad Street, Cumberland Avenue, Mary Street, Walnut Street, Willis Street, Smith Avenue and Westminster Avenue.

Mayor Washington, Sr., did comment on the open letter received from Walter L. Hudson, Sr., whereas Mayor Washington, Sr., appears to be concerned about the lack of security for the safety of the community within housing developments. Mayor Washington, Sr., would like to encourage such housing developments to increase security whether it be lighting, security cameras, etc., within the housing developments.

Mayor Washington, Sr., advised Borough Council of an upcoming presentation on July 16, 2019 by Paul Forlenza, CEO representing Tri-Co Jif. The topic of discussion relates to a contract renewal for membership with Gloucester, Salem, and Cumberland Counties Municipal Joint Insurance Fund.

Twenty-three (23) out of Thirty-Two (32) Units in Mallard Park Apartments, have been issued Certificate of Occupancy, six (6) of Thirty-Two (32) units awaiting re- Inspections, three (3) of Thirty-Two (32) units are vacant and under renovation. General office duties performed: One-Hundred-Three (143) e-mails were handled, seventy-three (73) Outbound, seventy (70) Inbound, sixty-seven (67) Recorded messages were received and processed, twenty (20) Housing/Zoning violation letters were issued Sixteen (16) First Time Notices, Four (4) Second and Final Notices Six (6) Summons to appear in court were issued: Four (4) for Zoning violations and Two (2) for Housing violations.

Mayor Washington, Sr., requested a motion from Borough Council to receive and file the Report submitted by Edward Ramsay, Housing/Zoning Inspector. Motion was moved by Councilman Washington, Jr., Councilman Pasquale seconded the motion. There was no discussion. All in favor, Motioned Carried by Mayor Washington, Sr.

General Government: Councilman Pasquale has been monitoring the unsafe structure on the corner of South Broad Street and Marry Street. He also mentioned that he submitted a work order to the Public Works Department, as it involves them to remove a tree from the middle of Naylor Avenue. He also brought up a conversation that he had with Officer Boucher about purchasing and upgrading weapons for the Penns Grove Police Department. Councilman Pasquale also noticed a monthly increase of Thirty-Three Thousand, Five hundred, Forty-one dollars and Seventy-Nine Cents (\$33,541.79) overtime hours within the Police Department where it has now become a County Issue. Investigation Overtime estimates about Six Thousand (6,000) Due to an understaffed Police Department these are the budget issues of the Borough of Penns Grove.

Public Works/Streets & Roads: Councilman Oliver was absent, therefore no report.

Public Safety: Council-President Poindexter was absent, therefore no report.

Buildings & Grounds: Councilman Leon was absent, therefor no report.

Recreation/Board of Health: Councilman Washington, Jr., had nothing to report.

SOLICITOR'S REPORT: Adam Telsey had nothing to report.

MUNICIPAL CLERK'S REPORT: had nothing to report.

FINANCE OFFICER'S REPORT: Ericka Walker, Assistant Treasurer reported the Budget Status Report Expenditure Ratio as of June 5, 2019 based on Temporary Budget is 86.19%

CHIEF OF POLICE REPORT: Chief Stranahan, notified Council that the guy in Police Academy will graduate in two weeks from this date. One of the Police Officers have been scheduled for surgery due to a prior incident, another officer will remain on light duty until the Attorney General says otherwise. Chief Stranahan gave forth his report for the Month of May, 2019: PGPD handled Seven-Hundred-Thirty-Six (736) Calls for Service, Thirty-Five (35) traffic stops, Twenty-One (21) traffic tickets issued, One (1) DWI arrest, Thirty-Seven (37) Adult warrant arrests, One (1) Juvenile arrest.

Sgt. Shultz and Ptl. Paul has been very active in all of the schools throughout the Month of May, where they've spent time teaching children about bicycle safety. The outreach unit has prepared a Bicycle Rodeo scheduled for this upcoming Saturday June 8, 2019 from 10:00 a.m. – 2:00 p.m. located at the Pointe Pontiac Dealership.

Chief Stranahan reported Three (3) different shooting incidents that took place within Penns Grove during the month of May, 2019. He advised Council that he is extremely concerned and revealed that out of town criminals have been invited by Penns Grove resident. One actor is incarcerated, one person has been identified and the witness does not want to testify against him. There was a homicide in Penns Grove Gardens, the subject is charged with murder and a fugitive.

Mayor Washington, Sr., requested a motion from Borough Council to receive and file the Report submitted by John T. Stranahan, Sr., Chief of Penns Grove Police. Motion was moved by Councilwoman Scott, Councilman Pasquale seconded the motion. There was no discussion. All in favor, Motioned Carried by Mayor Washington, Sr.

CHAPLAINS REPORT: Dewitt Timmons, informed the public to refer anyone who is seeking relief from Volunteers of America; there's an upcoming event July 29, 2019 Transportation will be offered to those in need.

FIRE CHIEF REPORT: Adam Hartsough was absent, therefor no report.

MAYORIAL REPORT: John Washington, Sr., made the Public aware that Lanning Avenue is in need of being repaved. He further mentioned that the Department of Transportation are responsible of selecting streets as well as authorizing grants for the Borough of Penns Grove. Mayor Washington, Sr., would like to get authorization from Council, to receive quotes for Oil and Stone.

Mayor Washington, Sr., believes that it is appropriate to call dress down until September.

Mayor Washington, Sr., would like to receive permission from Council to clean out the Street Department Building with his own clean-up crew, with no cost to the Borough. ("LRHL") and that certain Remedial Investigation Report approved by the Borough's Planning Board (the "Planning Board") on January 17, 2001; and

WHEREAS, by Ordinance, the Borough adopted the Broad Street/Main Street/Route 130 Study Area Redevelopment Plan (the "Redevelopment Plan"); and

WHEREAS, the Borough Council of the Borough of Penns Grove (the "Council") has reviewed the Amendment and Supplement to the Broad Street/Main Street/Route 130 Study Area Redevelopment Plan: Development Regulations for the "Wawa Redevelopment District" (the "Redevelopment Plan Amendment") attached as Exhibit A; and

WHEREAS, the Redevelopment Plan Amendment sets forth the use, bulk, intensity of use, and other development standards proposed to be applicable to the redevelopment of the "Wawa Redevelopment District" that is located within the Redevelopment Area (the "Wawa Redevelopment District") as detailed in the Redevelopment Plan Amendment; and

WHEREAS, the Wawa Redevelopment District is inclusive of those properties listed in the Redevelopment Plan Amendment; and

WHEREAS, the Council desires that the Planning Board of the Borough of Penns Grove (the "<u>Planning Board</u>") review the Redevelopment Plan Amendment and, within 45 days of the date of this Resolution, transmit a report to the Council containing the Planning Board's recommendation concerning the Redevelopment Plan Amendment in accordance with N.J.S.A. 40A:12A-7.e;

2019-6 – AN ORDINANCE IMPLEMENTING THE "AMENDMENT AND SUPPLEMENT TO THE BROAD STREET/MAIN STREET/ROUTE 130 STUDY AREA REDEVELOPMENT PLAN: DEVELOPMENT REGULATIONS FOR THE "WAWA REDEVELOPMENT DISTRICT" IN ACCORDANCE WITH THE LOCAL REDEVELOPMENT AND HOUSING LAW, N.J.S.A. 40A:12A-1, ET. SEQ. \*TITLE ONLY\*

WHEREAS, by Resolution, the Borough of Penns Grove (the "Borough") determined that the Broad Street, Main Street, Route 130 Study Area (the "Redevelopment Area") is an "area in need of redevelopment" in accordance with the New Jersey Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1 et seq. ("LRHL") and that certain Remedial Investigation Report approved by the Borough's Planning Board (the "Planning Board") on January 17, 2001; and

WHEREAS, by Ordinance, the Borough adopted the Broad Street/Main Street/Route 130 Study Area Redevelopment Plan (the "Redevelopment Plan"); and

WHEREAS, the Borough Council of the Borough of Penns Grove (the "Council") has reviewed the Amendment and Supplement to the Broad Street/Main Street/Route 130 Study Area Redevelopment Plan: Development Regulations for the "Wawa Redevelopment District" (the "Redevelopment Plan Amendment") attached as Exhibit A; and

WHEREAS, the Redevelopment Plan Amendment sets forth the use, bulk, intensity of use, and other development standards proposed to be applicable to the redevelopment of the "Wawa Redevelopment District" that is located within the Redevelopment Area (the "Wawa Redevelopment District") as detailed in the Redevelopment Plan Amendment; and

WHEREAS, by Resolution (the "Referral Resolution"), the Council referred the Redevelopment Plan Amendment to the Borough of Penns Grove Planning Board (the "Planning Board") for the Planning Board's recommendations consistent with N.J.S.A. 40A:12A-7.e; and

WHEREAS, the Planning Board considered the Redevelopment Plan Amendment at a duly-noticed public meeting; and

WHEREAS, the Planning Board thereafter transmitted to the Council a report (the "Planning Board Report") setting forth the Planning Board's recommendations with respect to the Redevelopment Plan Amendment within 45 days of the Referral Resolution in accordance with 40A:12A-7.e; and

WHEREAS, the Council considered the Redevelopment Plan Amendment and the Planning Board Report at its meeting of \_\_\_\_\_\_; and

WHEREAS, the Council desires to enact this Ordinance to implement the Redevelopment Plan Amendment; NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council as follows:

- 1. The Redevelopment Plan Amendment is hereby adopted and incorporated by reference herein.
- 2. The Redevelopment Plan Amendment and the zoning regulations and other standards contained therein are intended by the Council to supersede all other applicable zoning regulations for the Wawa Redevelopment District. The full text of the Redevelopment Plan Amendment is hereby specifically incorporated by reference as if fully set forth herein.
- 3. The Borough's official zoning map is hereby amended to identify and incorporate the zoning standards and other regulations set forth in the Redevelopment Plan Amendment consistent with N.J.S.A. 40A:12A-7.
- 4. All Ordinances or parts thereof inconsistent with the provisions of this Ordinance and the Redevelopment Plan Amendment are hereby repealed as to such inconsistency.
- 5. If any section, subparagraph, sentence, clause or phrase of this Ordinance or the Redevelopment Plan Amendment adopted hereby shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, sentence, clause or provision so adjudged and the remainder of this Ordinance and/or the Redevelopment Plan Amendment shall be deemed valid and effective.
- 6. This Ordinance and the Redevelopment Plan Amendment adopted hereby shall take effect upon passage and publication according to law.
