#### 2019-11-166 - RESOLUTION AUTHORIZING PARTIAL PAYMENT

WHEREAS, the Borough of Penns Grove awarded a contract to Landberg Construction, LLC for the Penn Street Phase II Roadway Improvements; and

WHEREAS, the Contractor has requested a partial payment in the amount of \$99,821.09 for construction layout, traffic cones, drums, constructions signs, the clearing site, mobilization, the concrete sidewalk, the 4" thick, and the concrete sidewalk, 6" thick; and

WHEREAS, the Borough Engineer has reviewed this matter and by letter dated October 29, 2019 recommends the partial payment of \$99,821.09; and

WHEREAS, the Borough agrees with the Engineer's evaluation of this matter;

Gary Green, Security & Surveillance, addressed the Ordinance regarding security; stating that the industry standard is 30 to 90 days versus the Borough's 180 day requirement. Green requested that the Ordinance be re-evaluated.

Patrolman Boucher concurred, stating that it has increased the quote by approximately \$40,000.00.

Nicholas Krauss, questioned the feasibility of the Borough accepting his property that was recently destroyed by fire.

Mayor Washington stated that that would be a decision made by the 2020 administration.

John Rambo, business owner, expressed concern regarding an incomplete project behind his establishment.

Oliver advised that he will make the appropriate contacts in an effort to resolve the matter.
