Buildings & Grounds – (Pasquale, Bercute) Pasquale stated/addressed the following: Water leak in Police Department under review; Computers moved from Public Works building for disposal.

General Government – (Mincey, Scott) Mincey addressed/stated the following: Office building closed until December 21, 2020 due to two COVID 19 positive employees; all employees required to have negative results before returning to work.

Housing/Zoning & Planning/Shade Tree - (Scott, Pasquale, Mincey) No report.

Parks & Recreation/Board of Health – (Bercute, Oliver, Pasquale) Bercute addressed/stated the following: 56 Ten-day notices issued, 13 resolved, 18 summonses issued; House decorating contest with award of \$500.00, \$250.00, \$150.00 and ten honorable mentions at \$20.00 each. Winners will be announced in January.

Public Works/Streets & Roads – (Oliver, Scott) Mincey addressed/stated the following: leaf pickup to occur once per month, with leaves to be placed on sidewalk.

Public Safety – (Mincey, Bercute, Scott) Mincey addressed/stated the following: Flooding along West Main Street drains were cleaned by county officials, however, awaiting communication from County Engineers regarding permanent resolution.

DEPARTMENTAL REPORTS:

Finance Officer Report – Labb addressed/stated the following: 4.25 percent increase in tax collection rate compared to November 2019 to November 2020. Working on CARES Grant for final reimbursement, which is approximately \$51,000.00.

Mayor addressed the total technology upgrade as well as conferencing equipment for the courtroom, which was covered by the CARES Grant.

Lieutenant Report – Spera addressed/stated the following: 838 calls for service, 76 motor vehicle summonses issued, 13 Borough ordinances, 32 arrests to include juveniles, and performed approximately 253 business/property checks during the month of November. Increased patrols in the area of Penn Towers, East/West Pitman Street, Penn Street and the Penn Food Mart. Staffing level decrease from 87.5% to 75%. Rise in overdose of heroine, fentanyl. Increase in motor vehicle theft within the Borough and surrounding counties and states. For the year of 2020, Officers responded to 11011 calls for service, made a total of 346 arrests, issued 482 motor vehicle summonses and issued 397 Borough Ordinances.

Mayor questioned stock of Narcan.

Spera stated well stocked and prepared.

Fire Chief Report – Hartsough addressed/stated the following: Santa coming to town on December 19, 2020 between 3:00 p.m. to 8:00 p.m. Questioned first responders' ability to obtain COVID-19 vaccination.

Lento advised that he will follow-up in that regard.

Ambulance/EMS Captain Report – Mincey addressed/stated the following: Extremely busy on transport and COVID cases have increased.

Mayoral Comment – Mayor Thomas addressed/stated the following: COVID-19 testing at the Penns Grove High School on December 4, 2020 and Borough Hall on December 5, 2020, with approximately 1000 participants. Expressed appreciation to the Penns Grove and Carneys Point Police Officers who assisted, teachers association and residents. Mayor's 2nd Annual toy drive will be hosted on December 20, 2020 at the Middle School, with Santa and elves on sleigh ride through town, live pony carousal for the children with all required to wear a mask, and safety

protocols in place. Expressed appreciation to outgoing council members for hard work and dedication during the past year.

Congratulations to newly elected John Rambo, Jonathan Carter and Charlyn Martin.

Attorney Report – Joseph Lento addressed/stated the following: Awaiting court decision on the Flameworks matter. Worked on several property sales. Negotiating Police contract. Working with the state to obtain the necessary doses of COVID-19 vaccination.
