Ron G, 7 Sack Ave, had some concern that the Borough will be going over state budget. Business Administrator Sean Brown stated the Council has to approve before the CFO to spend a certain amount form the budget, this will not expand the budget or cost the taxpayers.

COMMITTEE REPORTS:

Building and Grounds (Worley, Martin, Scarpaci) Councilwoman Worley addressed Mr. Sean Brown regarding the demo project. Mr. Brown advised that the list of properties will be rec=views to determine if it's necessary to rebid the project. Councilwomen Worley also addressed Mr. Brown regarding JIF's list of violations from 2021. Mr. Brown stated that we have had a lot of inspections this year and the list shows repeats, further advising that he will review the list to determine what needs to be abated.

General Government (Martin, Carter, Worley) Councilwoman Martin stated/addressed the following: Prayers for Bruce Willis and family. Committee met on March 8th, at which time they discussed obtaining EZ Pass and cross training Borough employees.

Housing/Zoning & Planning/Shade Tree (Rambo, Scarpaci, Martin) Councilman Rambo stated/addressed the following: LED lights are being considered for the on the Flag pole in Barber Ave Park. An electrician will need to look into what the Park needs to run the electric. CO request are up to date. Also, landlords are being notified to fill out a landlord registration form, so that the Borough can have this information on file. Tenants are unable to move in without a CO. Ten day notices have been sent out with hope by the end of May all trash and abandon cars to be under control.

Recreation/ Board of Health (Carter, Rambo, Mincey) Councilmen Carter stated/addressed the following: The Registrar Vital Statistics report for December, January and February. In December there were 17 certified copies of Death, 3 certified copies of Marriage and 1 certified copy of Birth, with a total of 12 cents interest earned and a total deposit of \$1,288. In January there were 29 certified copies of Death and 2 certified copies of Marriage with that a total of 1 cent interest was earned and a total deposit of \$1,740.01 In February there were 15 certified copies of Death, 5 certified copies of Marriage and 1 Marriage License, with 6 cents interest earned and a total deposit of \$1,153.06. Thank you to the Mayor and everyone who was able to come help last month with the food drive, it turned out to be a successful event. Councilmen Carter stated that an Easter egg hunt will be held at Barber Ave Park on April 16^{th.}

Public Works/Streets & Roads (Scarpaci, Mincey, Rambo) Councilwoman Scarpaci stated/addressed the following: The meeting with Carneys Point regarding the contract has been moved to sometime after Easter. Councilwoman Scarpaci asked when the Borough will award the contract for replacing the gutters at the Fire and Ambulance hall. Mr. Sean Brown responded and asked ask that this situation be discussed at the next Public Works meeting. Councilwoman Scarpaci also stated that she has been in touch with the mosquito commission and was told that the Borough is on their calendar but, the weather has been holding them up. The borough scheduled to have the ditches cleaned before April.

Public Safety (Mincey, Worley, Carter) Councilwoman Mincey stated/addressed the following: Public Safety interviewed two candidates for the police department, at this time they are in the process of getting background checks.

DEPARTMENTAL REPORTS:

Business Administrator Report: Sean Brown stated/addressed the following: The Cannabis Regulatory Commission announced two weeks ago that they approved their first set of conditional licensing. One of the licenses that were approved was an applicant that applied in Penns Grove. In the upcoming meetings the Borough needs to proceed with the Ordinances to regulate times of operation. Sean also stated that the housing and zoning page on the Boroughs website has been updated with, new jobs posted online.

Finance Officer Report: Ericka Walker stated/addressed the following: The introduced Budget Document along with supporting documentation was uploaded into the Fast System. The user friendly budget worksheet was uploaded in the Fast System on March 31st. The transitional Aid Application along with Appendix A thru M and supporting documentations were emailed to the Division on March 31st and on the morning of April 1st. Hard copies of all the documents should be delivered to the Division this Monday.

Police Director Report: Richard Rivera stated/addressed the following: The end of March monthly report was compared to March of last year's report. Burglaries have decreased 400%, Criminal Mischief was down 33%, domestic violence 33%, Car Stops went up, property checks have doubled, shots fired are down 50% and thefts went up this year.

Mayoral Comments: Mayor Thomas stated/addressed the following. Expresses thanks to all the officers for not going over the 2021 Budget. Also, the budget has had the biggest surplus it has had in over 20 years. In 2018 Penns Grove had a deficit of \$266,000.00 which tax payers had to pay back in the next year's taxes. In 2021 Penns Grove had\$709,000.00 in surplus. Penns Grove has raised over \$450,000.00 to demolish vacant properties and redo Barber Avenue Park with the support of Governor Phil Murphy.

Greg Martin, Spruce Street expressed concern on picking the roads that will be cleaned for Clean Communities.
