Resolution to Approve Proposal for Preliminary Assessment/ Environmental Due Diligence Services re: 76 South Virginia Avenue (Block 95, Lot 14)

WHEREAS, the "subject site," 76 South Virginia Avenue, listed as Block 95, Lot 14 on the Borough tax map, is listed in the New Jersey Department of Environmental Protection (NJDEP) Site Program as a *Known Contaminated Site* with a "Known Source or Release with Ground Water Contamination (PI #G00000 5398); and

WHEREAS, the Borough of Penns Grove desires to procure environmental due diligence services for the subject site addressed as 76 South Virginia Avenue (Block 95, Lot 14); and

WHEREAS, the Site Remediation Reform Act (SRRA) establishes criteria for the licensing of Site Remediation Professionals who will ensure that contaminated sites are remediated in accordance with the Technical Requirements for Site Remediation; and

WHEREAS, the Administrative Requirements for the Remediation of Contaminated Sites (ARRCS) require a "Person Responsible for Conducting the Remediation" (PRCR) to hire and maintain a "Licensed Site Remediation Professional" (LSRP) to manage the remediation of the subject site; and

WHEREAS, the tasked remedial phases in an environmental investigation subject to the NJDEP Technical Regulations and ARRCS are Preliminary Assessment (PA), Site Investigation (SI), Remediation Investigation (RI), Remedial Action (RA), and the issuance of a Response Action Outcome (RAO) by a PRCR's LSRP; and

WHEREAS, Remington & Vernick Engineers (RVE) has demonstrated that it has the inhouse capabilities to provide the necessary licensed professionals and undertake the required tasks; and

WHEREAS, RVE has submitted a proposal to provide the required services for a quoted amount of \$11,075.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Penns Grove that RVE is hereby authorized to undertake the required environmental due diligence services for the subject site addressed as 76 South Virginia Avenue (Block 95, Lot 14);
