COMMITTEE REPORTS:

Buildings & Grounds (Martin, Giordano, Rambo): Councilwoman Martin rode around to inventory and assessment of abandoned properties and will report what is Borough owned vs. Privately owned.

General Government/Clean Communities/JIF Fund/ Finance (Scarpaci, Martin, Giordano): Councilman Giordano recognized Steven Labb for his work so far on budget. In April will set up series for Clean Community Events sponsored by a grant from New Jersey Clean Community. Attended School Board Meeting and provided financial information. Instructed council to attend the JIF training. Mayor also stated for the JIF training to be attendance and for each member that attends the Borough will receive a \$250 credit per person.

Housing/Zoning & Planning/Shade Tree (Giordano, Martin, Rambo): Councilman Giordano states he sent as report to council. Discussed WaWa will start construction on the strip of stores for the businesses adjacent to the IGA. Auto Zone will begin construction after the sale of adjacent lot. Zoning Board received \$300 for CO's in January and \$600 in CO's for February.

Recreation/Board of Health (Carter, Mincey, Martin): Councilman Carter absent. Councilwoman Mincey reports for Board of Health – Summons to be heard – 3. 19 Ten day Notices to be sent out and 16 Ten Day Notices have been resolved.

Public Works/Streets & Roads (Rambo, Mincey, Carter): No report.

Public Safety (Mincey, Martin, Giordano): Councilman Mincey reports for Debbie Ashcraft – Reports 59 alarms and an increase in PCP use.

DEPARTMENTAL REPORTS:

Finance Officer Report: Stephen Labb, Chief Financial Officer/Treasurer reports the collection rate is up 1.28% and important dates are 4/6 the budget will be introduced and 4/9 transitional aid application due.

Public Safety Director Report: Lieutenant Spera 346 calls of service from March 1 through March 16, 2021 and 46 Business checks. The department is operating on a 75% staff due to medical of 2 officers, a resignation and a retirement. So far this year there were 1, 766 calls of service, 41 arrests, 99 motor vehicle summons, and 18 ordinance violations. Penns Grove police department has recovered more guns this year than all of the combined departments in Salem County.

FIRE CHIEF REPORT: Chief states that his heart goes out to the families with tombstones affected by the fire at the cemetery. The fire at Rivers Bend was due to a bonfire and urges residents to be aware of wind conditions etc.

EMS REPORT: Provided above by Council president Mincey

Attorney Report: Robert L. Tarver, Jr. states there are aggressive moves being set in place to protect the Borough.

Mayoral Comments: Mayor Thomas received a complaint regarding a fire alarm that has been going off for 3 weeks at SeaShore Produce, Chief advised they have made contact with the owner and he would not send anyone to the location and would not disarm the alarm. He said it has been ongoing for a year. Mr. Tarver added that it will be addressed quickly. Borough Hall is closed as both the Clerk and Deputy Clerk are out of the office indefinitely.

Third term Covid Vaccine for Salem County Residents 65 and older, Flyer is on the website. Call to register and transportation is available.

On March 29, 2021 Ascenda Health on Main Street is partnering with Family Success Center for Penns Grove, Carneys Point and Pennsville residents for Covid Vaccines, transportation available.
